

that hold a vast amount of the planet's biodiversity, yet are being rapidly destroyed. We target the  
highest priority areas for biodiversity, and work closely with local conservation groups  
for their purchase and protection. This year's grants enabled local organizations to buy  
create and manage areas of exceptional biodiversity value in Borneo, Brazil, Bolivia, Columbia, Ecuador,  
Panama & Paraguay.
