

Land purchase program: This program focuses on the purchase and
protection of the highest priority lands in the Americas for biodiversity
conservation, such as rainforests and similar endangered habitats. We
target the highest priority areas for the conservation of rare ecosystems
and endangered species, working with local conservation groups for
their purchase and protection. This years grants accomplished major
land purchases in Argentina, Bolivia, Brazil, Colombia, and Ecuador.

Reserve creation and land management program: WLT also focuses great
effort of new reserves and protected areas to conserve rainforests and
other critical areas in Latin America with local organizations. Our
efforts focus on saving Amazon rainforest and Andean cloud forests, two
of the earths richest biomes that hold a vast amount of earth biodiversity,
yet are being rapidly destroyed. This years grants were allocated to
conservation programs in Bolivia, Colombia, Ecuador, Paraguay and Peru.

Capacity Building of In-Country Conservation Organizations - One of WLT-US's
core philosophies is to build capacity of in-country conservation organizations
